### NEW REPORT DETAILS SPREAD OF COVID-19 THROUGH GLOBAL MINING INDUSTRY

A new report (attached) detailing COVID-19 outbreaks in mining facilities is accusing dozens of mining companies of prioritizing profit at the expense of the health of workers and local communities by continuing to operate during the pandemic.

The report released Tuesday aggregates data from more than 18 countries. Within Canada, many provinces listed mining operations as "essential" in March when shutting down workplaces and businesses in order to cut down on large gatherings in accordance with COVID-19 health precautions. Since the pandemic began, Francescone said, mining operations across the world have become "hotspots for transmission of the virus."

#### **EXPLORATION UPDATE: NIKKA DEPOSIT AT MCFAULDS**

In Fall 2019 we began a resource estimate to quantify the size and grade of the No. 8 Lens and provide updated resource estimates for the No. 1 and No. 3 Lenses. We also collected positioning data for the historic drill holes to help us create better geological modelling and brought in an independent geologist to provide an estimate on all three lenses. Because they are in close proximity, we consider these three lenses to be a single deposit with multiple zones. Going forward, we are calling it the Nikka Deposit. Nikka means Canada Goose in OjiCree and maintains the boreal forest bird theme that Noront follows in naming its various deposits. ### LEGAL EXPERTS CALL FOR HALT TO 'MINING AS USUAL' DURING PANDEMIC

The chief of Neskantaga First Nation, in northern Ontario, has previously requested the province press pause on mining exploration permits, citing concerns that his community does not have the resources to deal with permitting issues, while also dealing with the pandemic. In a written statement to CBC News, a spokesperson for the Ministry of Energy, Northern Development and Mines said the government acknowledges "the additional stress" placed on Indigenous communities in shoring up defences against the COVID-19 outbreak, and that regular communication is taking place to understand the challenges. The government is also "exploring means by which consultation can occur meaningfully and safely with communities without face-to-face meetings." "We are dealing with decisions on a case-by-case basis, have temporarily paused some permitting decisions where appropriate, and will continue to reassess the evolving situation," the statement continued.

Scott said she has questions about the government's case-by-case approach, and concerns about putting the onus on communities to ask for processes to be paused.

#### HISTORIC FRAMEWORK SIGNED FOR FIRST NATIONS-LED ATLANTIC WATER AUTHORITY

On Tuesday, the federal government signed an agreement that will transfer responsibility for water and wastewater services from Indigenous Services Canada to the Atlantic First Nations Water Authority (AFNWA). The First Nations-led water authority will act as a single utility provider for 15 Indigenous communities in the region, serving more than 4,500 households. This is the first framework of its kind in Canada.
