Throughout 2020, Greenstone Gold Mines (GGM) staff have been busy with a focus on completing detailed engineering and permitting of the Hardrock Project and initiating new exploration throughout the region. 

### **Environmental Permitting Approvals Progress**

Since the approval of the Environmental Assessment, GGM has been diligently working on preparing permit applications and receiving approvals at the federal and provincial levels.

Here is an overview of the permits and authorizations that GGM has received and what they mean for the Hardrock Project.



### What's Coming Next

GGM has submitted a number of permit applications to support later stage construction and mine operation requirements. We continue to work with government agencies through the permit review and approval processes. GGM appreciates the efforts of the government agencies in prioritizing the Hardrock Project. Additional permit approvals expected in late 2020 or 2021 include:


- Water Permits for construction of the Tailings Management Facility and the Goldfield Creek diversion
- Work Permit under the Lakes and Rivers
   Improvement Act for the Goldfield Creek
   Diversion
- ECA and PTTW for construction and operation of the Full Scale Effluent Treatment Plant, water management ponds, and the Sewage Treatment Plant
- Approval for the TMF dam locations under the Closure Plan
- ECA Waste for the onsite landfill

## **Engineering Update**

To date through 2020, GGM has made significant progress on advancing the detailed engineering of the Hardrock Project.

Detailed designs have been progressed for the process plant and main supporting infrastructure, as well as infrastructure relocations such as highway 11 and the MTO Patrol Yard.

GGM has also continued to engage with the Independent Tailings Review Board in advancing and verifying the design of the tailings management facility.



### Exploration Update


GGM's Exploration team has begun actively drilling in the Geraldton area. The team is testing various exploration targets on a number of our regional properties. GGM currently has 2 drills on site and are planning to drill 12,000 m. M3 Drilling, in partnership with Minodahmun Development LP, has been engaged to


complete the work with two diamond drills, focussed on completing the drill holes before the end of the year. The exploration team has also started some early stage prospecting and sampling in the Beardmore/ Jellico area on GGM's Brookbank property. The group is looking to develop exploration targets for potential follow-up next year.











The exploration program began in early September with the Environmental Technicians from local Indigenous communities performing frequent drill inspections.

An Environmental Technician from each community conducts at least one inspection audit per week and reports its findings to the team.


The inspections include examining general housekeeping, checking there are no leaks or spills from equipment as well as assessing environmental protections.



## **Environmental Program Update**

In September, the GGM team returned to the Project site to carry out routine environmental monitoring field work. The fall environmental monitoring program consists of surface water sampling, groundwater sampling and stream flow sampling.

In order for the team to return to work safely, GGM provided training on COVID-19 protocols being enforced at site.
